*Note:

1. Funds were supposed to be utilised for security deposits and construction advance to identified properties (as per sr. no 1) and unidentified properties (sr. no 3). However, since requirement of funds under serial number 1 is delayed and the company was required to take few properties to expand its business on lease rent and had to pay security deposit and construction advance to new properties (unidentified at the time of right issue) hence only interchange of use of funds under the objects and there is no change in the object.

2. There was increase in actual general corporate expenses as compared to corporate general expenses which was planned at the time of right issue.
